*Note to French speaking users: for technical considerations, the platform is only available in English, however, kindly be aware you can fill-in information in both Union Cycliste Internationale official languages: French or English.*

## **TEAM REGISTRATION DEADLINE AND PAYMENT – 15 JANUARY 2021**

### **a) Application criteria for UCI Mountain Bike Endurance and Gravity Teams is as follows:**

UCI Mountain Bike Endurance Team can apply for a registration only if the team is ranked with a total of minimum 75 points in the UCI endurance team ranking. The ranking is calculated as per article 4.11.006 and based on the riders individual UCI points in the first UCI XCO individual ranking of the season.

UCI Mountain Bike Gravity Team can apply for a registration only if the team is ranked with minimum 1 point in the gravity team ranking. The ranking is calculated based on the final individual world cup standings of the previous year and the world championships results by attributing points as per the table in article 4.13.002.

All teams must submit their application and pay the standard fee of EUR 2'500.- (for further details regarding the fees, please refer to the [UCI MTB Financial Obligations](#)). Payment should mention the exact name of the team it is related to.

### **COVID-19 specific provisions for teams registered in 2020:**

Following the particular 2020 season due to the COVID-19 pandemic, if your team was registered in 2020, the application criteria above do not apply, and you can register for 2021 even without the required points.

### **b) Application criteria for UCI Mountain Bike Marathon Teams is as follows:**

UCI Mountain Bike Marathon Team can apply for a registration from 2021 without any points requirements.

All teams must submit their application and pay the standard fee of EUR 1'200.- and, if a UCI Mountain Bike Endurance Team is already registered, an extra fees of EUR 500 is required to be UCI Mountain Bike Marathon Team (for further details regarding the fees, please refer to the [UCI MTB Financial Obligations](#)). Payment should mention the exact name of the team it is related to.

### **c) General information**

In addition, we also remind you that:

- a rider cannot be considered as a team manager or staff member of a UCI MTB Team.
- the general email address of the team should not be the same as a rider's email.
- a team must imperatively have a team manager to be registered.

**a) Team Name**

The “2020 TEAM NAME” field is prefilled-in with the current team name registered with the UCI and cannot be modified.

The “2021 TEAM NAME” field must be filled-in with the team name you wish to use for the 2020 season.

The “TEAM CODE (3 characters upon availability, only letters are allowed)” field must be filled-in with the team three-letter code you wish to use for 2021 season.

When this information is saved as draft or submitted, the team name and team code are updated and displayed on your dashboard.

**b) Team Manager**

When this information is saved as draft or submitted, it is updated and displayed on your dashboard (highlighted in light yellow). The Team Manager entered in this section must be the same as the one entered in the List of licensed Staff section.

**c) Details of the UCI team that will be published on UCI website**

Data is pre-filled in from previous season. Please make sure to check and update the information if needed before submitting. Please make sure to enter the absolute URL, including the leading *http://* or *https://* (example: <http://www.example.com>).

Please note that this information will be displayed on the UCI website and therefore, visible to anyone checking the website.

**d) Paying agent**

Data is pre-filled in from previous season. Please make sure to check and update the information if needed before submitting. Please make sure to enter the absolute URL, including the leading *http://* or *https://* (example: <http://www.example.com>).

**e) Main sponsors**

If you have several main sponsors (up to two), please make sure to fill-in the first main sponsor before filling-in the second main sponsor. When this information is saved as a draft or submitted, it is updated and displayed on your dashboard below the team category.

To ensure the integrity and image of cycling, the UCI has identified several categories of sponsors with whom stakeholders, including teams, may not be associated (directly or indirectly). Thus, article 1.1.089 of the UCI Regulations provides that:

“Without prejudice of the applicable law, no brand of tobacco, spirits, pornographic products or any other products that might damage the image of the UCI or the sport of cycling in general shall be associated directly or indirectly with a licence-holder, a UCI team or a national or international cycling competition.

As defined in the present article, a spirit is a beverage with a content in alcohol of 15% or more.”

In addition, article 1.1.090 of the UCI Regulations lays down certain conditions in relation to sponsorship by betting companies (including national lotteries). These conditions protect the integrity of cycling by reducing the risk of collusion and ensuring that visibility on cycling events is exclusively granted to betting operators whose activity does not cause a risk to the integrity of the sport.

The team seeking sponsorship by a betting company shall provide documentation establishing compliance with the conditions laid down in article 1.1.090 of the UCI Regulations with its request for registration before the UCI (the same applies in case the sponsorship is considered after the registration has been confirmed). We invite you to read this article carefully and remain at disposal.

**LIST OF STAFF MEMBERS - 15 JANUARY 2021**

There are two different sections in this task: list of licensed staff and list of non-licensed staff. All staff members contracted by the team, including on a temporary basis, licensed or not-licensed, must be registered in one of both lists.

Staff members who have a management role (Team Manager, Assistant Team Manager) must be licensed. We recommend that other staff members are licensed, but it is not mandatory.

The Team Manager listed in this section must be the same as the one listed in the Registration Information section.

Team Manager and Assistant Team Manager are prefilled-in from the current season on the list of licensed staff. Staff members who will not be contracted for the 2020 season can be removed from the list by clicking on the “X” button at the end of the line.

For each staff member, please open the individual line and fill-in and/or check the requested information. Please make sure to select the function which best fits the role of the staff member. You can then detail the different tasks of the staff member in the related field.

In order to add a staff member in the list of licensed staff, you can search the licence holder in the corresponding field or proceed with an advanced search.

The advanced search feature can help you in case there are several people with the same name. We kindly invite you to check the current licence of the person, on which the UCI ID is indicated. You can then select the correct person and add them to the list.

If there are several people with the exact same information (first name, last name, date of birth, nationality), please make sure to send the UCI ([support.ucidata@uci.ch](mailto:support.ucidata@uci.ch)) a print screen like on this example as well as a copy of the licence, showing the UCI ID, so that we can merge both entries and only have the correct one left.

If a person doesn't exist in the database after having searched, we kindly invite you to contact the relevant National Federation, that will be able to issue the correct licence. A UCI ID will then be created, and the person will be available in the database.

The UCI is well-aware that some functions don't require a licence to be issued. In this case, we kindly invite you to select the list of non-licensed staff. In this one, you cannot search in the database, as these staff members do not have a licence and thus do not have a UCI ID. You will have to create a new contact and fill-in standard information.


**JERSEY DESIGN - 15 JANUARY 2021**

- For a Gravity team: min. 2 riders and max. 10 riders
- For a Cross-country Olympic/Gravity team: min. 3 riders and max. 10 riders
- For a Cross-country Marathon team: min. 3 riders and max. 10 riders

Riders contract (in pdf) must be uploaded in the platform. The maximum file size is 1.5MB.

**PAYMENT - 15 JANUARY 2021**

UCI Mountain Bike Endurance and Gravity Teams must submit their application and pay the standard fee of EUR 2’500.- (for further details regarding the fees, please refer to the [UCI MTB Financial Obligations](#)). Payment should mention the exact name of the team it is related to.

All teams must submit their application and pay the standard fee of EUR 1’200.- and, if a UCI Mountain Bike Endurance Team is already registered, an extra fees of EUR 500 is required to be UCI Mountain Bike

Marathon Team (for further details regarding the fees, please refer to the [UCI MTB Financial Obligations](#)). Payment should mention the exact name of the team it is related to.
